Description of first aid measures

Place other contaminated materials in disposable containers and dispose of in a manner consistent with applicable requirements. Report spills to local authorities as appropriate or required.

SECTION 7 HANDLING AND STORAGE

General Handling Information: Avoid contaminating soil or releasing this material into sewage and drainage systems and bodies of water.
