SECTION 4 FIRST AID MEASURES

Skin: High-Pressure Equipment Information: Accidental high-velocity injection under the skin of materials of this type may result in serious injury. SECTION 6 ACCIDENTAL RELEASE MEASURES

Protective Measures: Observe all relevant local and international regulations. Eliminate all sources of ignition in vicinity of spilled material. Keep out unnecessary and unprotected personnel.
