## SECTION 4 FIRST AID MEASURES

### 4.1 Description of first aid measures

## IMMEDIATE SYMPTOMS AND HEALTH EFFECTS

This information is furnished upon condition that the person receiving it shall make his own determination of the suitability of the material for his particular purpose.**
